There shall be no interruptions when a member of the public has been granted the floor by the president of the council, and abusive speech and personal attacks shall be prohibited. An additional time for public comment for general matters not on the agenda under Borough control will be granted to the public at the end of the meeting for a period of no more than 30 minutes, once the items on the agenda have been addressed. The same rules of procedure as set forth above shall apply to this third segment of public comment. A copy of these rules of meeting decorum shall be provided to citizens at each meeting, as part of the agenda.
