Site Evaluation	\$100
Soil Probe (backhoe & operator to be provided by applicant)	\$200 (\$50 per additional pit same day)
Inspection Only	\$100
Perk Test (per every 6 holes)	\$400
Re-Use Certification/Reconnect	\$250 (includes 1 inspection for change of use or connection to existing system – existing and proposed flow analysis must be provided by applicant)
Verification of Prior Testing	\$150 (for testing completed over 6 years ago)
Portable Toilet	\$25 (per toilet)

Permit Renewal	\$150 (prior to 3-year expiration, after expiration new permit fees apply)
